Pharmacy First	Service Income	August 2024	The activity threshold of clinical pathway consultations increases to 20 per month for August 2024. This means you have to provide a minimum of 20 consultations that pass the gateway point to be eligible for the £1,000 monthly payment.	
Pharmacy First	Service Income	By the 5 th of the month	Remember to claim every month for service activity via MYS.	
Flu Vac: PGD and National Protocol Published	Service Income	2024/25 Flu Programme	The patient group direction (PGD) for the 2024/25 flu vaccination season has been approved by NHS England and will enable pharmacy technicians to provide flu vaccinations this coming season. Find out more here
