<b>Pharmacy First</b>	Service Income	<b>January 2025</b>	<ul style="list-style-type: none"> <li><a href="#">Changes to the Pharmacy First payment thresholds have been made for the rest of the year. The threshold for February is 25.</a> A minimum of 25 consultations are to be completed to pass the gateway point to be eligible for the £1,000 monthly payment.</li> </ul>	
<b>Advance Services Bundling</b>	Service Income	<b>31<sup>st</sup> March 2025</b>	From the 31 <sup>st</sup> March 2025, community pharmacies must deliver a bundle of services to qualify for the monthly £1,000 payment. This includes: <ul style="list-style-type: none"> <li>Pharmacy Contraception Service</li> <li>Hypertension Case Finding Service</li> <li>Pharmacy First</li> </ul>
