Pharmacy First	Service Income	January 2025	Changes to the Pharmacy First payment thresholds have been made for the rest of the year. The threshold for February is 25. A minimum of 25 consultations are to be completed to pass the gateway point to be eligible for the £1,000 monthly payment.	
Advance Services Bundling	Service Income	31 st March 2025	From the 31st March 2025, community pharmacies must deliver a bundle of services to qualify for the monthly £1,000 payment. This includes: Pharmacy Contraception Service Hypertension Case Finding Service Pharmacy First
