Annual Complaints Report	Contractual	As soon as reasonably practicable after the end of 2024/25	Pharmacy owners must send a copy of their annual complaints report to the local NHS contract management team.  This is a mandatory requirement for all pharmacy owners	
Pharmacy First Service	Service Income	31 <sup>st</sup> March 2025	Deadline for pharmacy owners who are delivering Pharmacy First to also deliver the Pharmacy Contraception Service and Hypertension Case-Finding Service to qualify for the monthly £1,000 fixed payment (as well as meeting the relevant consultation threshold)	
Pharmacy Profile Update	Contractual	1st April – 30th June 2025	Ensure your Directory of Services and NHS website profiles are up to date by updating your NHS Profile  Manager  The new quarter starts 1st April 2025 and ends on the 30th June 2025 but we encourage you to do this as soon as possible
